0 Einführung // Introduction

0.1 Anleitung zum Gebrauch der Synopse // Instructions on using the Synoptic Table

Nachdem von Papst Franziskus am 19. März des Jahres 2022 die neue Apostolische Konstitution über die Römische Kurie „<i>Praedicate Evangelium</i>“¹ erlassen worden war, stand längere Zeit eine umfängliche Revision der seit 1999 zwar immer wieder modifizierten, aber in jüngster Zeit nicht an die neue Rechtslage angepassten Geschäftsordnung der Römischen Kurie [„Regolamento Generale della Curia Romana“ (= RegGenCR/1999)]² aus. Am 23. November des Jahres 2025 schließlich war es soweit: Papst Leo XIV. erließ zur Modifikation des veralteten Regolamento gleich zwei neue Regolamenti, nämlich erstens das neue „Regolamento Generale della Curia Romana“ (= RegGenCR/2025)³ sowie zweitens das „Regolamento del	After the promulgation of the new Apostolic Constitution on the Roman Curia „<i>Praedicate Evangelium</i>“ by Pope Francis on 19 March 2022,¹ a comprehensive revision of the “Regolamento Generale della Curia Romana” (=RegGenCR/1999)², which – despite some amendments since 1999 – had not recently been brought into line with the new legal framework, remained pending. Finally, on 23 November 2025, the long-awaited revision was completed. Pope Leo XIV promulgated two new Regolamenti to replace the outdated one: 1. the new “Regolamento Generale della Curia Romana” (= RegGenCR/2025)³, and 2. the “Regolamento del Personale della Curia Romana”

Personale della Curia Romana" (= RegPersCR)⁴, mit welchem dem Inhalt des ersten Teils („Parte Prima“) des RegGenCR/1999 nunmehr ein eigenes Dokument gewidmet ist. Die vorliegende Synopse hat nun zum Ziel, aufzuzeigen, inwiefern die Normen des RegGenCR/2025 und des RegPersCR der alten Rechtslage entsprechen. So vermag der Nutzer einen ersten Eindruck zu bekommen, inwiefern die neue Rechtslage sich überhaupt von der alten Rechtslage unterscheidet. Es werden Symbole verwendet, um auf den Grad der Entsprechung hinzuweisen und somit ein erstes Vergleichsergebnis zu bieten. Beim RegGenCR/2025 werden zudem stichpunktartig manche relevante Veränderungen zitiert. Die Synopse besteht aus zwei Teilen: Der erste Teil geht von der neuen Rechtslage aus (linke Spalte) und stellt ihr die alte Rechtslage gegenüber (rechte Spalte). Er ist daher unterteilt in: 1.1 RegGenCR/2025 vs. RegGenCR/1999 1.2 RegPersCR vs. RegGenCR/1999. Der zweite Teil hingegen geht von der alten Rechtslage aus, dort bildet das RegGenCR/1999 die linke Spalte.	(=RegPersCR)⁴, which is now devoted exclusively to the subject matter previously contained in Part One ("Parte Prima") of the RegGenCR/1999. This synopsis aims to show the extent to which the provisions of the RegGenCR/2025 and the RegPerCR correspond to those of the previous framework. It intends to provide users with an initial overview of the differences between the new and the previous legislation. Symbols are used to indicate the nature of the equivalence, thereby providing an initial comparative result. Regarding the RegGenCR/2025, some relevant changes are also cited in keywords. The Synopsis is divided into two parts: Taking the new legal framework as a starting point (left column), the first part compares it to the previous legal framework (right column). It is therefore divided into the following undersections: 1.1 RegGenCR/2025 vs. RegGenCR/1999 1.2 RegPersCR vs. RegGenCR/1999. In the second section, the previous legal framework forms the starting point. Accordingly, the RegGenCR/1999 is placed in the left column.
